ORDER

In continuation to Order No. F.9(24)/DWCD/Admn/Misc./2009/7910-19 dated 24.07.2025, the sanction of Competent Authority i.e. the Secretary, DWCD, is hereby conveyed for continuation of the following additional 06 temporary posts of Supervisor Grade I w.e.f. **01.04.2025 to 31.03.2026**. These posts have been created for State Cell, Five District Cells and 95 ICDS Projects, for implementation of Saksham Anganwadi and Poshan 2.0 (erstwhile Integrated Child Development Scheme (ICDS) in the Department of Women and Child Development, GNCT of Delhi during 1976-2026. The details of the posts, project-wise, being continued are as under:-

Earlier, the Competent Authority i.e. the Secretary, DWCD has concurred the Continuation of 31 posts of Supervisor Grade I in ICDS Projects w.e.f. 01.04.2025 to 31.03.2026 which is conveyed by the Department's Order F.9(24)/DWCD/Admn/Misc./2009/7910-19 dated 24.07.2025. The total 37 posts of Supervisor Grade I have been continued under Saksham Anganwadi and Poshan for the FY 2025-26 w.e.f. 01.04.2025 to 31.03.2026.

The above extension of posts is subject to the following conditions:-

1. That budget/ funds are released by Government of India and GNCTD during 2025-26 for the ICDS Projects.
2. That provision of funds to meet the expenditure on salary and allowance/ honorarium of the staff is made in the relevant Budget Head of the scheme during 2025-26.
3. Funds as allotted in Budget are released by Govt. of India and Govt. of Delhi during the FY 2025-26.
4. Posts are required for due discharge of the duties for implementation of the project during the relevant period for which the continuation is approved.
5. The Project for which the posts are created remain operational during the relevant period.
6. That the posts exists in the revised staffing pattern of the Scheme as



per Govt. of India guidelines.

7. The order is valid in respect of the posts which are not lying vacant for more than five year or the posts which remain vacant for more than five year and subsequently revived by the Competent Authority from time to time.
8. To ensure that the salaries/wages must be released against the posts for which the concurrence of the Competent Authority is received for FY 2025-26.

Expenditure involved on meeting the expenditure on salary & allowances and honorarium in respect of above posts shall be debitabale to respective Head of Accounts of Saksham Anganwadi and POSHAN 2.0 i.e (CSS, Salary) CSS-2235-02-102-17-98-01, Saksham Anganwadi and POSHAN 2.0 (Salary) State Share (Plan) 2235-02-102-16-98-01 and Honorarium to Anganwari Workers and Helpers 2235-02-102-17-98-02 Wages (CSS) & 2235-02-102-15-98-02 wages (State Head) for the Financial Year 2025-26.
