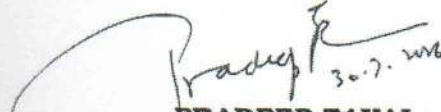
Sub: Endorsement of copies of Notifications/Gazette Notifications and Policy Related Orders to the Office of the Hon'ble Chief Minister.
