CORRIGENDUM

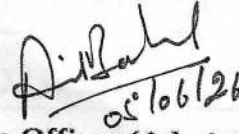

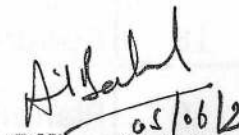

I am directed to refer to the Compliance Reduction and Deregulation Exercise, GNCTD, Phase II, and to inform that Policy Action (PA)-22, relating to creation of a Centralised Digital Repository of all State Acts, Rules, Regulations and Government Orders and subsequent review on receipt of proposal based on a principle-based framework, has been assigned to the Law Department.

In this regard, all Departments are requested to furnish at the earliest, preferably within 07 working days, the following information/document:

- 1 *Accurate, updated and editable* soft copies of all Acts, Rules, Regulations, Schemes, Notifications, Circulars and Government Orders, framed under any Delhi Act or applicable Central Act and administered by the Department in terms of the six enumerated principles under PA 22.
- 2 Identify all Rules, Regulations, Schemes, Notifications, Circulars and Government Orders which are either outdated or redundant after due diligence and holistic consideration with respect to accuracy.

The above information may kindly be furnished in soft copy to the Law Department within the stipulated timeline, so as to enable consolidation and submission of a roadmap to the O/o the Hon'ble Chief Secretary by 06.02.2026.

The cooperation of all Departments in this important reform exercise is solicited.
