ORDER

The DDO before claiming their monthly remuneration shall verify the facts that the staff have actually worked in the Home/Institution upto the entire satisfaction of the concern HOOs and work appraisals are on records.

The remuneration of the aforesaid contractual Counsellors shall be regulated in accordance with the Finance Department's O.M. dated 20.01.2017 and shall be payable at the rate of the minimum pay of the applicable pay level of the respective post, along with admissible

Dearness Allowance (DA).

(DA as applicable with effect from 01.01.2025 shall be payable for the period from 03.04.2025 to 31.03.2026, and DA as applicable with effect from 01.01.2026 shall be payable for the period from 03.04.2026 to 31.03.2027.)

The concern DDOs/HOOs shall ensure that the remunerations of employees are released after obtaining the attendance reports from their physical place of postings.

Compensatory leave would be allowed to those officials who performed their duties during 01st April & 02 April during 2025-26 & 2026-27.

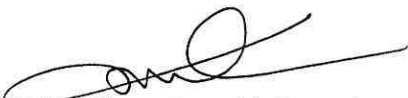
