Sub.-Regarding compliance of an order no. F.10(183)/2014/DSW/Estt/15988-16038 dated 01.12.2014 and recovery of wrongful/excess payment (If any).

In pursuance of the order of Hon'ble CAT in OA 2270/2012 in MA 1838/2012 titled Krishna Kumari & Ors Vs. Dr. Satbir Bedi, Secretary, GNCTD & Ors dated 03.04.2013 and on the recommendations of Departmental Promotion Committee, 32 Supervisors Grade-II were upgraded to the post of Supervisor Grade-I on notional basis vide order no. F.10(183)/2014/DSW/Estt/15988-16038 Dated 01.12.2014, as per their seniority in the Pay Band-2 of Rs.9300-34800 with Grade Pay Rs.4200/- (Rs.5500-9000 pre-revised) with effect from the dates (notionally) mentioned against their names in column number 07 and they were entitled for monetary benefit with effect from the date of their joining (The date of eligibility mentioned in the column 07 of the said order, enclosed herewith).

However, it has been noticed that some of the Supervisors mentioned in the said order dated 01.12.2014 have been paid monetary benefits from the date of their eligibility instead of their date of joining as mentioned in the said order.

In this regard, a case has been filed by Mrs. Krishna Kumari in the Hon'ble CAT bearing O.A. No. 3683/2016 titled Krishna Kumari Vs Govt of NCTD and pending before the Hon'ble CAT, wherein, she prayed for getting arrears w.e.f. 01.01.1996 i.e. date of eligibility, similarly as paid to other Supervisors.

As in the order dated 01.12.2014, it was clearly mentioned that the Supervisors Gr.-II upgraded to the post of Supervisor Grade-I will be entitled for monetary benefit with effect from the date of their joining, all concerned DDOs/HOOs of the supervisors mentioned in the order dated 01.12.2014 are, hereby, directed to check the records and ensure they have been paid the monetary benefit with effect from the date of their joining.



Further, if any Supervisor Grade-I has been paid the monetary benefits other than their date of joining, the over payment (from date of eligibility to date of joining) may be recovered and submit a compliance report in Administration Branch, WCD (HQ) within seven days.

This issues with the prior approval of the Director, DWCD, GNCTD.
