ORDER

In continuation to Order No. F.9(24)/DWCD/Admn/Misc./2013/Part-II/11865-74 dated 21.10.2024, F.9(24)/DWCD/Admn/Misc./2013/Part-II/8674-79 dated 02.09.2024 and F.9(24)/DWCD/Admn/Misc./2013/Part-II/2158-67 dated 10-05-2023, sanction of Competent Authority is hereby conveyed for continuation of the following additional 23 temporary posts of Jr Assistant/LDCs w.e.f. 01.04.2024 to 31.03.2025. These posts have been created for State Cell, Five District Cells and 95 ICDS Projects, for implementation of Saksham Anganwadi and Poshan (erstwhile Integrated Child Development Scheme (ICDS)) in the Department of Women and Child Development, GNCT of Delhi during 1976-2025. Earlier, Finance Department has concurred the Continuation of 28 posts of Jr. Assistant/LDCs in 95 Projects, 01 Post in State Cell and 05 posts in five District Cell under Saksham Anganwadi and Poshan Scheme for FY 2024-25 w.e.f. 01.04.2024 to 31.03.2025 vide UO Number 135-DS(III) dated 23.08.2024 which is conveyed by the Department's Order F.9(24)/DWCD/Admn/Misc./2013/Part-II/8674-79 dated 02.09.2024. The total 57 posts of Jr. Assistant/LDCs have been continued under Saksham Anganwadi and Poshan Scheme by Finance Department, GNCTD for the FY 2024-25 w.e.f. 01.04.2024 to 31.03.2025.

The above extension of posts is subject to the following conditions:-

1. That budget/ funds are released by Government of India during 2024-25 for the ICDS Projects.
2. That provision of funds to meet the expenditure on salary and allowance/ honorarium of the staff is made in the relevant Budget Head of the scheme during 2024-25.
3. Funds as allotted in Budget are released by Govt. of India and Govt. of Delhi during the FY 2024-25.
4. Posts are required for due discharge of the duties for implementation of the project during the relevant period for which the continuation is approved.
5. The Project for which the posts are created remain operational during the relevant period.
6. That the posts exist in the revised staffing pattern of the Scheme as per Govt. of India guidelines.
7. The order is valid in respect of the posts which are not lying vacant for more than one year or the posts which remain vacant for more than one year and subsequently revived by the Competent Authority from time to time.
8. To ensure that the salaries/wages must be released against the posts for which the concurrence for Finance Department, GNCTD is received for FY 2024-25.

Expenditure incurred on meeting the expenditure on salary & allowances and honorarium in respect of above posts shall be debitable to respective Head of Accounts of Saksham Anganwadi and POSHAN 2.0 i.e. (CSS, Salary) CSS-2235-02-102-17-98-01.
