CIRCULAR

In reference to the circular dated 08 Aug 2024 wherein it was requested to upload/update and generate completion certificate in PPIS module to provide details of manpower of their respective office for the Delhi Assembly Election 2025. For this purpose office level users shall have to fill (new)/update (existing) information in PPPIS module, in respect of regular government employees, Cadre/ex-cadre physically posted in their office (as per Annexure 'A'). It was also conveyed that the said information must be completed by 12.08.2024.

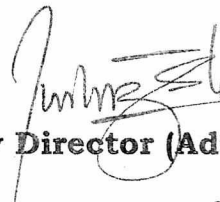
However, many offices/branches under the jurisdiction of DWCD, GNCTD have not submitted data in PPIS and not generated completion certificate yet despite repeated whatsapp and telephonic reminders.

Now, the last date of uploading/updation and generation of completion certificate in PPIS module has been fixed as 31.08.2024, after which no further extension in dates will be made.

In view of above, all Deputy Directors/Branch in Charges, DWCD HQ, All District Officers /Supdt./CDPOs of concerned offices District Offices/Homes/Institutions/JJBs are directed to upload/update and generate the completion certificate on **31.08.2024 by 11:00 am. Non compliance the time line will recommend stringent disciplinary action against the concerned Officer to Election Commission of India, without any further notice.**

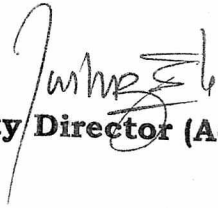
