
The DDO before claiming their monthly remuneration shall verify the facts that the staff have actually worked in the Home upto the entire satisfaction of the concern HOOs and work appraisal are on records.

The DA rate is 55% applicable w.e.f. 01.01.2025 in r/o the remuneration to the employees engaged against the posts of Para Medical Staff (Physiotherapist/Nursing Officer), House Father/Mother and Welfare Officer. This rate shall remain same till the expiry of contract period.

As per instructions of Department conveyed vide order No. 01/DWCD/P.B./Misc./2015-16/28545-604 dated 13.10.2015 concern HOO/DDOs shall ensure that remunerations of employees are released after obtaining their available attendance reports from their place of physical postings. All the DDOs shall ensure that the remuneration of above staff is released against the sanctioned vacant posts of their respective category. Their services shall be discontinued as and when the regular nominated candidate given appointment.


