Sub.:-Regarding compliance of an order no. F.10(183)/2014/DSW/Estt/15988-16038 dated 01.12.2014 and recovery of wrongful/excess payment, if any.

In reference to the above-cited subject, this Department vide letter No. F.13(146)/WCD/Admn/OA No. 3683/2016/5154-63 dated 12.06.2025 had directed all concerned DDOs/HOOs to ensure compliance with the Order dated 01.12.2014 within **seven (07) days**. However, no compliance report has been received from any of the concerned DDOs/HOOs to date.

1. In this regard, attention is again invited to the Order dated 03.04.2013 of the Hon'ble CAT in OA No. 2270/2012 in MA No. 1838/2012 titled *Krishna Kumari & Ors. vs. Dr. Satbir Bedi, Secretary, GNCTD & Ors.*, pursuant to which and on the recommendations of the Departmental Promotion Committee, **32 Supervisors Grade-II** were upgraded to the post of **Supervisor Grade-I** on notional basis vide Order No. F.10(183)/2014 /DSW/Estt/15988-16038 dated 01.12.2014.
2. As per the said order, the upgraded Supervisors were placed in the Pay Band-2 of ₹9300-34800 with Grade Pay ₹4200/- (pre-revised ₹5500-9000) with effect from the dates (notionally) mentioned in Column No. 07 of the enclosed order. It was clearly stipulated that **monetary benefits** shall be admissible **only from the date of joining** to the upgraded post, and **not from the date of eligibility** mentioned in Column No. 07.
3. It has, however, come to notice that in certain cases, monetary benefits were incorrectly released from the date of eligibility instead of the date of joining, in contravention of the order. As a result, a case titled *Krishna Kumari vs. Govt. of NCT of Delhi* (OA No. 3683/2016) is pending before the Hon'ble CAT, wherein the applicant has sought monetary benefit from the date of eligibility on parity with other such instances of payment.
4. In view of the above, all concerned DDOs/HOOs are hereby **directed to:**

- Scrutinize the service records of the Supervisors mentioned in the Order dated 01.12.2014.



- Verify that monetary benefits have been released only from the date of joining, in accordance with the said order.
 - In cases where excess payment has been made (i.e., from date of eligibility to date of joining), take immediate steps to recover the overpaid amount.
5. A **compliance report**, along with details of recovery (if any), must be submitted to the Administration Branch, WCD (HQ) **within four (04) days** positively for onward submission to the Higher Authority.
 6. It is further stated that **non-compliance** with these directions shall invite **strict action under relevant rules** against the DDO/HOO concerned.
 7. **This may treated as most urgent/Court Matter.**
