## <u>Term of reference for Chairpersons and Members of Child Welfare</u> <u>Committees</u>

Online applications in the prescribed format are hereby invited from eligible and intending applicants for the positions of Chairperson/Members of the Child Welfare Committee (in short "CWC") in respect of the all districts of Delhi from residents of Delhi. (A candidate can apply only for one post)

- 1. No person shall be appointed as a member of the Committee unless he has a degree in child psychology or psychiatry or law or social work or sociology or human health or education or human development or special education for differently abled children and has been actively involved in health, education or welfare activities pertaining to children for seven years or is a practicing professional with a degree in child psychology or psychiatry or law or social work or sociology or human health or education or human development or special education for differently abled children.
- 2. The candidates applying for the honorary post of Chairperson and Members should be above the age of 35 years and not more than 65 years of age.
- 3. The duties of Child Welfare Committee call for full time sitting from 10:00 Am to 5:00 PM on all working days.
- 4. A Chairperson and Member of a Committee shall be eligible for appointment of maximum two terms, which shall not be continuous
- The Chairperson/ Member of the Committee will be paid honorarium of Rs. 3500/- per sitting or as decided by the Government.
- 6. In addition to this the State Government has the power to terminate the services of any Member of CWC at any point of time in accordance with the provisions of the Juvenile Justice (Care & Protection of Children) Act, 2015 and Juvenile Justice (Care & Protection of Children) Act, 2021 & Rules, 2016 and Juvenile Justice (Care & Protection of Children) Amendment Rules, 2022.
- 7. Chairperson/Members selected by the Selection Committee should meet the criteria as envisaged in Sub-Rule 5 of Rule 88 Juvenile Justice (Care & Protection of Children) Model Rules, 2016.
- 8. No person shall be eligible for selection as a member of the Committee, if he—
  - (i) has any past record of violation of human rights or child rights,
  - (ii) has been convicted of an offence involving moral turpitude, and such conviction has not been reversed or has not been granted full pardon in respect of such offence,

- (iii) has been removed or dismissed from service of the Government of India or State Government or an undertaking or corporation owned or controlled by the Government of India or State Government,
- (iv) has ever indulged in child abuse or employment of child labour or immoral act or any other violation of human rights or immoral acts, or
- 9. The person applying for the post of the Chairperson or member of the Committee shall submit an affidavit, as per Form 49, certifying that the applicant is not barred by any of the conditions laid down in sub- section 4A of section 27 of the Act. The appropriate Government shall then verify the same as per norm.
  - (i) A person associated with an organization receiving foreign contribution shall not be eligible to be a Chairperson or member of the Committee.
  - (ii) Any person working in the implementation of the Act in any Non-Government Organization or any organization, performing such functions which may cause conflict of interest in discharge of their duties as the Chairperson or member of the Committee shall not be eligible for appointment as the Chairperson and member of the Committee.
- 10. Explanation: For the removal of doubt, it is hereby clarified that, this may include but is not limited to any of the following situations within the territorial jurisdiction of the Committee:
  - (a) any family member is a member of any non-governmental organization;
  - (b) close relation is a member of any non-governmental organization;
  - (c) cases of non-governmental organizations or persons working in a district for rescue and rehabilitation;
  - (d) a person representing a person who runs a Child Care Institution or member of the Board or Trust of any non-governmental organization.
- 11. The State Level Selection Committee shall evaluate the candidates on the basis of qualifications, experience of working with children and personal interaction with the applicant and recommend a panel of names one for the position of the Chairperson and another for the position of Members in order of merit to the State Government for appointment as Chairperson or Members of the CWC to fill up the subsequent vacancies arising if any.

- Social Worker Members shall have at least seven years of experience of working with children in the field of education, health, or welfare activities, or should be a practicing professional with a degree in child psychology or psychiatry or sociology or in the field of law.
- 2. The candidates applying for the honorary post of Member Social Worker should be above 35 years of age and shall not be more than 65 years of age on the date of notification.
- 3. The Member Social Worker of the Board will be paid honorarium of Rs. 3500/- per sitting or as decided by the Government.
- 4. The duties of Member Social Worker call for full time sitting from 10:00 Am to 5:00 PM on all working days.
- 5. A Member Social Worker of a Board shall be eligible for appointment of maximum two terms.
- 6. In addition to this, the State Government has the power to terminate the services of any Member Social Worker of juvenile Justice Board at any point of time in accordance with the provisions of the Juvenile Justice (Care & Protection of Children) Act, 2015 and Model Rules 2016.
- Member Social Worker selected by the Selection Committee should meet the criteria as envisaged in Sub-Rule 5 of Rule 88 Juvenile Justice (Care & Protection of Children) Model Rules, 2016.
