Minutes of Meeting

A meeting was convened on Thursday, 28th December 2023 at 12:00 PM under the chairmanship of Director, DWCD. Also present in the meeting was Additional Director (WCD). Besides, District Officers/Officials of District Office, Dy. Director (Coordination/I.T), Dy. Director (RTEG), Dy. Director (Admin.), Dy. Director (FAS) and officials of FAS Branch also attended the meeting.

The following issues were discussed in the meeting:-

- Discussion on the jurisdiction of 11 District Offices of the WCD co-terminus with the Revenue Department.
- ➤ Locality mapping as per Revenue Department on e-District Portal & NSAP portal.
- > To reach upon a conclusion regarding the issues raised by the District Officers.

At the outset respected Director, DWCD invited the suggestions of the District Officers with respect to their constituency areas. It was unanimously agreed that District jurisdiction will be as per the revenue District jurisdiction but constituency shall be the basic criteria and in case of constituency areas falling in two Districts, it shall be assigned to District in which Larger portion of area is falling and as mutually discussed and agreed in the meeting.

The summary of Discussion and suggestions given by District Officers/Official of the District Office and Deputy Director, (HQ) are as under: -

- District (Central): The constituency 'Rajinder Nagar' and 'Patel Nagar' do not fall under District (Central) as per the Revenue Department and 'Rajinder Nagar' and 'Patel Nagar' may be mapped with District (New Delhi).
- District (South West): The constituency 'Nagloi Jat', 'Mundka' do not fall under District (South West)as per the Revenue Department and some applications of beneficiaries living in Constituency 'Nagloi Jat are being received on the e-District portal in District (South West). The constituency of Nangloi Jat and

'Mundka' may be mapped with District (West) and Janakpuri with South West..

- District (East): As per the Revenue Department, the constituencies 'Gandhi Nagar and Krishna Nagar' constituencies geographically fall in District (East). It was suggested by the District Officer that the constituency 'Gandhi Nagar' and 'Krishna Nagar' may be mapped with District (East).
- District (South & South East): The constituency 'Malviya Nagar' falls under District (South) but some applications of beneficiaries living in Constituency of 'Malviya Nagar'are being received on e-District portal in District (South East).
- District (North): The constituency 'Wazirpur', 'Shakur Pur Basti' and 'Rohini' do not fall under District (North). The constituency 'Wazirpur', 'Shakurpur Basti' and 'Rohini' may be mapped with District (North West).
- District (North West): The constituency 'Bawana' Falls under District (North).
- Deputy Director (Coord. /IT) branch has suggested that constituency Rajinder Nagar may be mapped with District (New Delhi) and Patel Nagar may be mapped with District (West) as more areas of the constituency fall under the above district.

Decision taken by Worthy Director, DWCD:

It is observed that localities of 22 constituencies fall under two Districts as per the Revenue Department. The Department implements schemes namely "Delhi Pension Scheme to Women in Distress" and "Indira Gandhi National Widow Pension Scheme" through NSAP portal, both the schemes are running a on constituency basis on the NSAP portal and where only one constituency comes under only one district office. Therefore, in consultation with District Officers, Dy. Director (RTEG), Deputy Director, (FAS) and Deputy Director (Coord. /IT) the following decision was taken by worthy Director, DWCD:

- The constituency 'Rajinder Nagar' will mapped with District (New Delhi).
- The constituency 'Patel Nagar' will mapped with District (West).
- The constituency 'Gandhi Nagar' and 'Krishna Nagar' will mapped with District (East).
- The constituency 'Greater Kailash' will mapped with District South.
- The constituency of Bawana will be mapped with District North and the constituencies of 'Wazirpur', 'Shakur Pur Basti' and 'Rohini' will be mapped with District North West.
- The remaining constituencies will be mapped with one of the two districts in which the greater part of the constituency falls.

- > The IT branch will solve the technical problems arising in remapping.

 (Action to be taken by IT Branch)
- ➤ The shifting of District 'New Delhi' may be put on hold as the construction of office space at the Department of WCD complex, Delhi Gate, is in progress and the office of DCPU(N.D) and CWC (N.Delhi) be shifted to Delhi Gate.

(Action to be taken by District (New Delhi))

- > The FAS branch will remap the District and Constituency on the NSAP portal.

 (Action to be taken by FAS Branch)
- > All District Officers will send the monthly report of the LADLI Scheme in the new format.
- ➤ It was directed to District Officer (N.E & Shahdara) and Estate Branch Head Quarter to immediately take steps for vacation of Sanskar Ashram Office premises from Socal Welfare Department so that the office of District Shahdara may be started there
