ORDER

The Hon'ble Lt. Additionally HRA & TA will also be payable on basic pay in view of order dated 20/03/2023 followed by corrigendum dated 06/04/2023 issued by this department in compliance of order/judgment dated 21/04/2015 passed by Hon,ble CAT in OA No. 2050/2014 & OA No. 1326/2015.
