ORDER

Whereas, in compliance of order dated 19.02.2023 of Hon'ble CAT in the matter titled Rameshwar Prasad and ors. in OA No. 1630/2014 Vs. GNCTD and order dated 16.01.2023 of Hon'ble High Court of Delhi in the matter titled GNCTD & ors. Vs. Rameshwar Prasad & ors. in WPC No. 445/2014, an Order dated 01.02.2024 was issued to all Concerned DDOs/HOOs, DWCD with direction to examine the individual cases and fix the payment of salary and arrears in r/o of regular Cooks and to provide the confirmation letter by 12.02.2024.

Whereas, a subsequent reminder dated 26.02.2024 was issued to all concerned DDOs/HOOs with a direction to provide the Action Taken Report by 29.02.2024. However, confirmation letter from concerned DDOs/HOOs is still awaited.

Whereas, the instant CONT. CAS (C) No. 799/2023 titled Nanda Ballabh Vs. Sh. Naresh Kumar, Chief Secretary has been listed before Hon'ble High Court on dated 07.03.2024 in which the Hon'ble Court has directed "*last opportunity of six weeks is granted to the respondent to do the needful. It is made clear that in case the requisite amounts are not released to the petitioner within a period of six weeks, the concerned officer shall be present in Court on next date of hearing i.e. 08.05.2024.*"

The concerned DDOs/HOOs are hereby again directed to provide the Action Taken Report to Joint Director (Admn.), DWCD latest by 20.03.2024 failing which the same will be considered as non-compliance and strict action will be initiated as per rules.
