**Order**

This is continuation of order vide no. F.No. 16(33)/DWCD/ADMN/Misc./2022/PF/24854-58 dated 22.03.2023 in furtherance of a policy decision taken by the Chief Secretary, GNCTD, The Department of DWCD has taken a decision to function as per Revenue District Jurisdiction.


In order to make the 11 districts of WCD fully functional and to enable the processing of flagship Financial Assistance Schemes of the Department on the E-district portal the following actions are required to be taken by all concerned in a time bound manner:

- i. District Officers to dispose of all applications of the schemes namely Delhi Pension Scheme to Women in Distress and Widow Daughter Marriage Assistance Scheme, which are pending at verification and approval stage within 10 days of the issue of this order. New applications received in the above 02 schemes namely Delhi Pension Scheme to Women in Distress and Widow Daughter Marriage Assistance Scheme are not to be processed for verification till completion of area location remapping on E-District portal since processed cases cannot be transferred.
- ii. In respect of Ladli Scheme the old pattern will be continued till the end of the financial year as the date for submission of applications has already been extended under Ladli Scheme to 30<sup>th</sup> November 2023 and processing of these applications as per original alignment may continue. Schools & SBIL team to continue to coordinate with original District Offices. New Applications from the next financial year can be submitted to new districts setup. The registration of new DDO Codes by Ladli branch will be initiated immediately and budget be reallocated to the concerned DDO along with redistribution of Ladli beneficiaries as per alignment.
- iii. FAS branch to remap the localities as per the order dated 22.03.2023 regarding WCD district jurisdiction co-terminus to the Revenue district Delhi.



- iv. After remapping, the pending new applications unprocessed due to above exercise by the District Officer will be transferred to concerned districts by FAS branch.
- v. As remapping of 11 district on NSAP portal is not complete due to inaction by the Department of Social Welfare, the existing NSAP portal will be utilized as 11 districts are already there on NSAP portal wherein District South East already exist and since North West – I and North West – II will stand merged as North West hence the North West – II portal will be utilized for District Shahdara. However, this will be a stop gap arrangement and FAS branch to coordinate with Department of Social Welfare for proper naming of Districts on NSAP portal in a time bound manner.
- vi. The existing District office of New Delhi will shift with all infrastructure to Department of WCD Complex, Delhi Gate (Behind Arun Jaitley Stadium) where at present District Central is located. The District Office Central along with all infrastructure and staff will shift to Department of WCD office at Ground Floor Gulabi Bagh office where at present District North is functioning. District North with all infrastructure and staff will shift to DWCD Complex at Sewa Kutir. The office of North West – II will stand merged with North West – I and will be now called District North West and functional from same place i.e. F block, DWCD Office, Mongolpuri. The entire exercise of shift shall be completed within 15 days of issue of this order.
- vii. Admin branch is required to issue orders for posting of officers in newly created districts i.e. District Shahdara and District South East.
- viii. Till suitable space arrangement is made, District South East will be run from Lajpat Nagar premises and District North East and District Shahdara from Sanskar Ashram Complex Premises under dual charges.
- ix. The staff posted at District North West – II may be utilized for the 02 new districts.
