ORDER

In furtherance of the earlier Order dated 20.03.2023 and Corrigendum dated 06.04.2023, approval of the Competent Authority is hereby conveyed for payment of allowances as applicable to the regularly appointed Welfare Officer i.e. House Rent Allowance (HRA) and Travel Allowance (T.A.) to the contractual Welfare Officers other than the applicants in O.A. No.2050/2014 " Shashank Singh Tomar & Others Vs Shri Vijay Kumar Dev and in O.A. No. 1326/ 2015 " Devraj Singh & Others Vs Shri Keval Kumar Sharma & Others" are working in the Department of Women and Child Development, GNCTD, as resolved, with effect from 07.04.2015 i.e. date of filing of latter OA No.1326/2015.

However, the contractual Welfare Officers shall not be entitled to any increment or promotion or regularization, and shall get pay at the minimum of the regular pay scale only.

The Expenditure involved on this account for payment of arrears w.e.f. 07.04.2015 would be debit able to the concerned Head of Account of the respective DDO from where these contractual Welfare Officers are drawing salary which shall be released upon proper verification of the credential of the incumbents.
