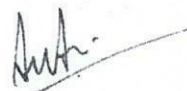

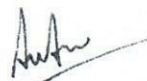

Sanction of the Finance Department, GNCTD for release of 1st instalment of GIA amounting to ₹30.00 lakh under Head of Account 2235 02 102 31 00 36-GIA-Salaries and ₹70.00 lakh under Head of Account 2235 02 102 31 00 3 1-GIA-General during CFY 2025-26 to Delhi Commission for Protection of Child Rights subject to the compliance of FD's OM dated 18.07.2011, pattern of assistance, MoU, observance of all the codal formalities, provisions of GFR-2017 and instructions/guidelines issued by GNCTD/GoI/FD/CVC etc from time to time conveyed vide UO No. ds3/40 dated 02.06.2025 as per details given below: -

The Drawing and Disbursing Officer of the Department is authorized to draw the amount of Grant-in-Aid to the tune of Rs. 1,00,00,000/- (Rs. One crore Only) for transfer to Delhi Commission for Protection of Child Rights through RTGS.

The Grant-in-Aid is being released subject to the following conditions:

1. Due Prudence and frugality shall be exercised by the grantee institution while incurring expenditure out of GIA and no wasteful expenditure whatsoever shall be incurred in any manner.
2. Expenditure shall be incurred only for the purpose of salary for which GIA has been sanctioned and for the targets, which have been assigned to the grantee institution by the Administrative Department.
3. The DCPCR shall submit a utilization certificate duly signed by the executive head to the department.
4. The DCPCR shall follow adequate control mechanism/checks for prevention and detection of errors and financial irregularities in its working/functioning.
5. The DCPCR shall ensure that the mechanism/checks contemplated are effectively applied for ensuring that the funds are utilized for the prescribed purpose only.
6. Further, DCPCR shall ensure the observance of procedure and fulfilment of conditions as laid down in Government Order No. F12/3/2010-AC.12/3/2010AC/dsfa/dsIII/914-921 dated 18/07/2011 issued by the Finance Department.

7. All audit report and action taken on settlement of audit paras shall be submitted to the department at the earliest.
8. The expenditure involved on this account shall be debitible from the Budget Head 22 02 102 310036 GIA-Salaries and 2235 02 102 31 00 3 1-GIA-General for Child Rights Commission.
