ORDER

Subject: Constitution of Committee for realignment of Jurisdictional Boundaries of Department of Women & Child Development as per Revised Revenue District Boundaries.

The Department of WCD is in process to realign its existing administrative structure of 11 Districts with the newly notified Revenue District boundaries of 13 Districts. In this regard, an office order dated 09.01.2026 was issued by the Worthy Secretary, WCD, in compliance with the directions of the Chief Secretary, GNCT of Delhi vide order dated 26.12.2025.

In order to realign the existing ICDS Projects as well as Anganwadi Centres as per revised districts, it is imperative to get input from the field functionaries as they are in possession of adequate knowledge of their respective areas.

The realignment exercise needs to be conducted with utmost diligence to ensure uniformity, proper distribution of ICDS projects and Anganwadi Centres across each new district.

Accordingly, a Committee is hereby constituted by incorporating representative from each district to examine and facilitate the realignment of the existing 95 ICDS projects including 10,897 AWCs with new Revenue District boundaries.

1. To examine both the existing and revised Revenue District boundaries and to map Anganwadi Centres with the corresponding ICDS Projects and sub-divisions.
2. To suggest a new project and district wise administrative setup that matches the newly defined Revenue District boundaries.

3. To suggest a plan of action for smooth transition, including reshuffling of staff, records, and resources, to ensure minimum disruption in service delivery to the beneficiaries in the system.
