In compliance of the direction of Hon'ble High Court, Delhi vide its order dated 09.10.2019 passed in W P (C) No. 214/2015 & CM Appeal No. 337/2015 Court Case titled "GNCTD & Ors. Vs Kiran Sharma & Ors." followed by the approval of Competent Authority, **Mr./Ms. Archana Singh (D.O.B – 01.03.1977) Category- UR** after being declared medically fit by the Medical Board, DDU Hospital vide letter No. F.1(1)/DDU/MB/2023/20876 dated 29.05.2023 & receipt of verification of Character and antecedents by the concerned Police Authorities Vide U.P. GVR No. 921 dated 30.06.2023 stated nothing adverse against her, is hereby appointed to the post of Protection Officer in the Pre-revised Pay Band 9300-34800 with Grade Pay of Rs. 4200/- (Revised Pay Matrix Level-6 Rs.35400-112400) plus usual allowances as admissible under the rules from time to time. His/Her candidature is purely provisional and subject to fulfilling all the conditions of eligibility for the post and on the following terms and conditions:-

- 1 The appointment is fully governed by the terms and conditions already conveyed to the candidate in the offer of appointment dated 04.05.2023 duly accepted by her.
- 2 The appointment is provisional and is subject to the case/tribe/community certificate being verified through proper channels and If the verification reveals that the claim to belong to Scheduled Caste/Scheduled Tribe/Other Backward Class, as the case may be, is false, the service will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificate.
- 3 This appointment shall be subject to the legal remedies available to the Department of Women & Child Development, GNCT of Delhi, whenever required.

The candidate is directed to furnish an undertaking to this effect at the time of joining of duties, failing which the candidate shall not be allowed to join duties.

Mr./Ms. Archana Singh is hereby directed to report for joining of duties in Women & Child Development, within **05 days** of receipt of this order failing which her appointment is likely to be stand cancelled without any further notice.

This letter of appointment is served in special circumstances. It can not be taken as precedence for other appointments.
