Amend/09-10/ 26/11/10 as following, namely:-

1. Short title, extent and commencement:-

(1)These Rules may be called The National Capital Territory of Delhi Pension Scheme to Women in Distress in the age group of 18 to 60 years (Amendment) Rules 2012

2. Amendment of Rules 7 (i)

In Rule 7 (i) of the said Rules, the words "One thousand Five Hundred" shall be substituted for the Word "One Thousand"

3. Amendment of Rule 12(1)

In Rule 12(1) of the said Rules, the following shall be added. "She will receive equal financial assistance under Old Age Pension Scheme

These shall come in to force from the current financial year w.e.f.01/04/2012
