Amend/09-10/ 21/09/2006, 6/5/2008 ,28/10/2009, and 30/06/2011., as following, namely:-

1. Short title, extent and commencement:-

- (1) These Rules may be called The Financial Assistance for the marriage of daughters of poor widows and orphan girls (Amendment) Rules2012.
- (2) These shall be deemed to have come in to force on 1st day of April 2012.
- 2. Amendment of Rule 2:- In the Financial Assistance for the marriage of daughters of poor widows and orphan girls Rules 2006, in rule 2, in sub-rule (1) in clause (a) after the words "Poor Widows" the words "divorced, separated, abandoned, deserted or destitute women" shall be inserted.
- 3. Amendment of Rule 4:- In the said Rules in rule 4 for the words "Twenty Five" the word "Thirty" shall be substituted.
- 4. Amendment of Rule 6:- In the said Rules in rule 6, in sub rule (4) in clause (a) the following words shall be inserted in the end, namely: - "For divorced/ separated/ abandoned or deserted women, divorce decree, any legal proceedings including reports in the police station, Crime against Women Cell, Family Counselling Centers (FCC), Delhi Commission for Women, National Commission for Women, Mahila Panchayats shall be admissible."

- 1. Short Title, Extent & Commencement:
- (1) Financial Assistance for the Marriage of Daughters of Poor Widows and Orphan Girls Amendment Rules 2011.
- (2) They shall come into force from the current financial year,
- In the Financial Assistance for the Marriage of Daughters of Poor Widows and Orphan Girls Rules 2006 therein after referred as the said Rules, in Rule 3 the following shall be substituted;
  - Rule 3: The District, Social Welfare/Women & Child Development Officers or Jt. Director, FAS shall be the competent authority for verification and sanction of the payment under the scheme. In case of existing widows who are getting pension, the competent authority may satisfy him/herself about the contents of the application by screening the documents submitted, by the applicant. In doubtful cases only, the competent authority may get the verification conducted through the departmental investigators. In case of non pensioners, the competent authority may get such verification done as deemed necessary through departmental investigators.
- In the said Rules, in rule 4 the words "Twenty Five Thousand" shall be substituted for the words "Twenty Thousand".
- 4. In the said Rules, in Rule 8 the words "Director Women & Child Development" shall be substituted for the words "Director Social Welfare".
