NOTIFICATION

No.F1(4)/FAS/WDM/DSW/05-06 - The Lt. Governor of the National Capital Territory of Delhi is pleased to make the following rules for the scheme of providing the Financial Assistance for the Marriage of Daughters of Poor Widows and Orphan girl to enable them to meet the expenses involved in solemnizing the marriage, namely:-

- Short Title and Commencement.-
 - (1) These rules may be called the Financial Assistance for the Marriage of Daughters of Poor Widows and Orphan Girls Rules 2006.
 - (2) They shall come into force with immediate effect.
- 2. Ains and Objective._ (1) The aims and objectives of these rules are -
 - (a) to provide financial Assistance to the poor widows for performing the marriage of their daughters.
 - (b) to provide financial assistance to the guardians including Homes/ Institutions or foster parents of an orphan girl or to an orphan girl for her marriage.
- 3. COMPETENT AUTHORITY. The District Social Welfare Officer of the concerned District shall be the Competent Authority for sanction, verification of the contents of the application and the financial position of the applicant. The Competent Authority may satisfy himself about the content of the application by conducting such verification as deemed necessary by any departmental official or other officials specially deputed for the said purpose.
- 4. Manner of As istance. The Competent Authority may, subject to the provisions of these rules, grant an amount of Twenty Thousand Rupees only time financial assistance:
- Condition for Financial Assistance. For grant of financial assistance under these rules, the applicant must fulfill the following conditions, namely:-

- (a) The applicant must be bonafide resident of the National Capital Territory of Delhi for, at least, five years preceding the date of application.
- (b) the applicant shall not have the family income more than forty eight thousand rupees per annum from all sources:
- (c) The applicant should not be in receipt of any assistance from the discretionary fund of the Lt. Governor or the Chief Minister of Delhi for the same purpose.
- (d) The girl, for whose marriage the financial assistance is sought, should be major on the date of marriage.
- (e) In case of widow applicant the financial assistance can be granted for performing marriage of up to two daughters only.
- Application for Financial Assistance:- (1) An application for the financial assistance under these rules shall be submitted to the Competent Authority, in the prescribed Form, which may be obtained from the office of the Competent Authority or from the office of the Dy. Director (FAS), Department of Social Welfare, GLNS Complex, Delhi Gate, New Delhi.
 - (2) The application shall contain the recommendation from the Member of Legislative Assembly of National Capital Territory of Delhi or the member of the parliament of the area concerned.
 - (3) The application shall be submitted at least, Sixty days, before or after the date of marriage.
 - (4) The following documents shall be attached with the application:-
 - (a) In case of widow applicant a copy of the death certificate of her husband issued by the Registrar Births & Deaths;
 - (b) A copy of ration card or voter identity card or any other proof of residence;
 - (c) Income certificate issued by Revenue Authority of jurisdiction;
 - (d) A proof of age of the girl in the form of school leaving certificate or date of birth certificate issued by Registrar of Births & Deaths;
 - In case of orphan gir! grown up on her own, an affidavit on stamp paper duly attested by a Metropolitan or Executive Magistrate or a Notary or a certificate from a Gazetted Officer to the effect that she is an orphan.
 - (f) In case of girl brought up by a guardian or foster parent or the relative, such persons or guardian should submit the affidavit to the effect that the girl is an orphan and he/they have brought her up;
 - (g) A marriage invitation card of the marriage for which the financial assistance is sought.
 - (h) An affidavit to the effect that no financial assistance has been received by the applicant from any other Govt, organization, nongovernment organization, Municipal Corporation of Delhi or Now

Delhi Municipal Corporation or any other statutory or non-statutory agency for this purpose.

- Intimation regarding change of address: The applicant shall intimate any change of address along with of address with proof to the Competent Authority within one month of such change.
- Appellate Authority:- In case of grievances, the applicant may appeal to he Director, Department of Social Welfare for redressal of his/her grievances in this regard.
