Proposal for amendments in the "Delhi Pension Scheme for Women in Distress" of Department of Women and Child Development.
The Council of Ministers considered the note of Secretary (SWWCD). After deliberations, the Cabinet approved the following:

- 1 (i) Pension to women in distress shall be continued till 31.08.2016. Upper age limit of 60 years was removed. However, such a beneficiary will not be eligible for the age group of 60 years and above.
- (ii) The income criteria to be eligible for the pension for women in distress will henceforth be Rs. 1.00 lakhs per annum (from all sources). While calculating the income, only the income of widow/women in distress from all sources will be counted.
- 2 The Cabinet also approved in-principle increase in the cap of old age pension (maximum number of beneficiaries) by 1 lakh. The distribution among various Assembly Constituencies shall be worked out by the Department and proposal brought before the Cabinet at the earliest.

Beneficiaries under 1 & 2 above shall have to furnish Aadhaar number and Aadhaar seeded bank account shall be a must for transfer of pension. However, the existing beneficiaries (women in distress) can be allowed to provide Aadhaar number/Aadhaar seeded bank accounts within a period of one year failing which their pension shall be stopped.
