The State Child Protection Society- Delhi, Department of Women & Child Development, Govt. of NCT of Delhi, invites Expression of Interest from Delhi based NGO's for running Shelter Home for Children in Need of Care and Protection for Grant-in-Aid under Integrated Child Protection Scheme for the year 2015-16.

Preference will be given to the proposals for shelter home for children specifically in the priority order as listed below:-

1) Children in Begging

2) Children in Drug Addiction/ Substance Abuse

3) Girl Street Children

4) HIV affected Children

**Eligibility Criteria:** 

- a) Registered / licensed NGO's
- b) NGO's with min. three years experience in the field of child care, welfare, and protection or running children's Home / Shelter Home for children

**Important** 

The proposal should include:

- 1) Details / description of the locality and address of the proposed project (Shelter Home)
- \* Preference will be given to NGO's who can demonstrate proof of possession of premises to run the shelter home
- 2) Plan for rehabilitation of inmates
- 3) Plan for de-addiction services for inmates
- 4) Audited statement of Accounts for last 3 years

The Department would encourage NGO's with experience in child protection, who bring along a partner experienced in providing de-addiction / counseling for children.

The NGO's may apply for GIA under ICPS for existing shelter homes and for new proposed shelter homes The NGO's running open shelter under the scheme can also move proposal to convert existing open shelters in to full fledged shelter home.

The financial assistance will be provided to NGOs/ voluntary organizations for establishing such shelter homes as per the detailed and revised Integrated Child Protection Scheme guidelines of the Ministry of Women & Child development. Inviting "Expression of Interest" from NGOs for running Shelter Home under ICPS for the Financial Year 2015-16

While a large number of urban marginalized children are in need of day care services, there are many others who require residential care for a temporary period for one or more reasons. These include children without parental care, children in begging, trafficked, run away children, migrant children, and child substance abusers, differently abled children/ mentally challenged children and any other vulnerable groups of children.

The Juvenile Justice (Care and Protection of Children) Act 2000 empowers State Governments to recognize reputed and competent voluntary organizations, to serve the children in need of care & protection. The State Government provides financial assistance to set up and administer Shelter Homes for such children. These shelter homes shall offer day and night shelter facilities to the children in need of support services for a temporary period, while efforts are made to rehabilitate them.

Thus, the State Child Protection Society- Delhi, Department of Women & Child Development, Govt. of NCT of Delhi, invites Expression of Interest for running a Shelter Home for Children in Need of Care and Protection for Grant-in-Aid under Integrated Child Protection Scheme for the year 2015-16.

Preference will be given to the proposals for shelter home for children specifically in the order listed below:

- Children forced in to begging
- Children in Drug Addiction/ Substance Abuse,
- Girl Street Children,
- HIV affected Children.

The NGOs may apply for GIA under ICPS for existing shelter homes and for new proposed shelter homes. But for proposed shelter home, NGOs having good experience in child protection will be preferred. The department will also prefer institutions which can demonstrate tangible arrangements/ tie-ups for

- Space (specifically identified space to be demonstrated),
- Educational/ Schooling/ Remedial Education tie-up,
- Counseling Facilities,
- Health tie-up,
- Vocational Training,
- Career Counseling,
- Hobbies/ Sports.

Proposals in the prescribed format along-with two sets of relevant documents in support of the status of the NGOs/ VOs and their proposed activities should be submitted in person/ by hand on or before 15<sup>th</sup> July 2015 latest by 5.00 p.m. in the office of the State Child Protection Society- Delhi, Department of Women and Child Development, Govt. of NCT of Delhi, 1A Canning Lane, K.G. Marg, New Delhi -110001.

#### **Note:**

- Shortlisted NGO's will be called for a presentation of their project against which the proposal is submitted.
- Proposed Shelter Homes, if granted fund, will have to apply for a license under Juvenile Justice (Care & Protection of Children) Act, 2000 within one month of operationalization.

#### General Instructions for the Voluntary Organizations/NGOs Applying for Shelter Home under ICPS

- 1. Application should be submitted in the prescribed format only (See Annexure I (Form A): For Existing Shelter Home/ Annexure II (Form B): For Newly Proposed Shelter Home). The application not filled in the prescribed format shall be summarily rejected.
- 2. Applicant Voluntary Organizations/ NGO are advised to ensure that they fulfill eligibility criteria prior to submission of application (as mentioned in the advertisement and also to ensure that the NGOs/ Voluntary Organizations is registered/ licensed under relevant legislation).
- 3. NGOs having experience of not less than three years of working in the field of child care, protection and rehabilitation will be preferred.
- 4. Availability of space/ premises for running such Shelter Home according to ICPS Guidelines/ Juvenile Justice (Care & Protection of Children) Act, 2002 and its amendment will also be taken in account.
- 5. Each and every page of the application and enclosures must be numbered and signed by the authorized signatory with the seal of the organization.
- 6. NGO must submit two copies of applications/ proposals in two separate office file covers.
- 7. Incomplete Applications/ documents shall not be considered.
- 8. Application submitted after last date / due date shall not be considered.
- 9. Last date of submission of application is 15<sup>th</sup> July 2015, latest by 5:00 p.m.
- 10. The Member Secretary of State Child Protection Society, Delhi reserves the right to amend/ alter/ change/ modify any or all of the conditions if necessary or cancel the advertisement with or without assigning any reason thereof.
- 11. The selection of proposal will be done by the Project Selection Committee of ICPS whereas release of Grant-in-Aid for the year 2015-16 for running the Shelter Home to recommended proposals shall be subject to the approval of the Project Approval Board of Ministry of Women and Child Development, Goyt, of India.
- 12. The financial assistance will be provided through the State Government/ UT Administration to voluntary organizations for establishing such shelter homes as per the detailed and revised ICPS guidelines. Kindly refer the website of Ministry of Women and Child Development, GOI (www.wcd.nic.in) for financial norms under ICPS.
